



## **IMPORTANT VISA INFORMATION FOR TRAVELERS TO INDIA**

Dear Traveler,

As you prepare for your upcoming tour with Immersion Journeys, we would like to inform you that visas are required for your visit to India. This visa must be obtained in advance of your departure from the United States. We have enclosed customized visa instructions from G3 Global Services, LLC, the visa service we recommend.

As the Indian online application is difficult to navigate, the custom instructions include a visa questionnaire and an order form from G3. To apply through G3, please complete the included forms and e-mail them to [Immersion@g3visas.com](mailto:Immersion@g3visas.com) or fax to 866.611.6960. A G3 associate will then complete the online application for you and will email (or mail) it back so you may print, sign and include it in your package to G3.

**We recommend that you apply for your visa 6-10 weeks prior to your US departure.** Please use a delivery service with a tracking number, such as FedEx or USPS Express Mail, when sending in your passport and documents to the visa service.

Please ensure that your passport has at least two blank pages marked "Visas" and will be valid for at least six months following your tour. G3 can assist with passport renewals and replacements of lost or damaged passports, if necessary.

### STEP 1 - Email to [Immersion@g3visas.com](mailto:Immersion@g3visas.com)

Please complete this **order form** (one per family) and the enclosed **India Visa Questionnaire** (one per guest) and email it to G3 at [Immersion@g3visas.com](mailto:Immersion@g3visas.com), along with scans of the **information/photo page of your valid passport** and your **driver's license**. A G3 associate will complete your India application online and email you a PDF of the application to print, sign, and include in your package. You may also opt to fax your questionnaire to G3 and receive your completed application by US Mail. Please allow three business days for your India application to be completed and emailed to you. The completed online application must be returned to you before you progress to Step 2 below.

### STEP 2 - Ship Hard Copy Documents

After you receive the completed online India application from G3, you should review it for accuracy, then sign in ink. An accompanying letter will provide a detailed list of items to return to G3 with your signed application and passport. Please use a trackable overnight delivery service, such as FedEx or UPS, to ship these items to our office. If you would like to begin preparing those materials, they are as follows:

- Your valid, signed US passport. Your passport must have two sets of blank pages labeled "Visas."
- Two 2" x 2" passport size photos (two identical) with white background. Do not wear glasses in the photo.
- A copy of your international flight itinerary.
- A photocopy of your valid driver's license or a major utility bill (gas, electric or water) in your name that matches the address on your visa application form. The address must be a street address, not a PO box. PLEASE NOTE: your passport with the completed visa will be returned to this address by the Indian visa office.
- Additional documentation may be required; a final list of requirements will be sent with your completed India application.

*Your passport will be returned to the residential address shown on your proof of residence (driver's license or utility bill) via Federal Express. FedEx delivers to residential addresses with no signature required; G3 will email you tracking information so you may anticipate your delivery.*

**Visa Validity:** Your India visa will be issued for multiple entries; most US citizens are issued visas valid for 10 years with multiple entries. Your Nepal visa will be valid for multiple entries over a 15 day period.
